Launched in 2025, the Nauru Economic and Climate Resilience Citizenship Program (ECRCP/NECRCP) offers a unique route to second citizenship. By contributing to the Nauru Treasury Fund, investors directly support vital climate resilience projects, including the Higher Ground Initiative, safeguarding the nation's future. This program provides enhanced global mobility, significant family inclusion, and a cost-effective Plan B, all while contributing to environmental sustainability.

Languages: Nauruan, with English widely spoken

Economy: Small, developing; focus on diversification & climate resilience

Currency: Australian Dollar (AUD)

Safety: Safe and low crime rate

Tax Benefits: Favorable tax regime (no income/capital gains/inheritance tax)

Key benefits



Visa-free or visa-on-arrival travel to approx. 88-91 countries, including the UK and UAE



Affordable investment threshold; Politically neutral "Plan B" passport



Include spouse (incl. unmarried partners), children (up to 30), dependent parents & grandparents (55+), unmarried siblings

Program overview

- Minimum contribution from USD 105,000 (Non-refundable Treasury Fund option).
- No minimum stay or visit requirements, before or after citizenship.
- Launched Jan 2025, focused on funding climate resilience and sustainable development.



Procedures

The Nauru Program Office, operated by Henley & Partners, processes all applications. The process includes mandatory due diligence and an interview, which can be done virtually.

- ① Engage Citiverse as your authorized agent
- ② Citiverse guides document preparation (passport copies, police clearances, medical certificates)
- ③ Application prepared & submitted to Nauru Program Office via Citiverse with initial fees
- ④ Mandatory virtual interview conducted (applicant 16+)
- ⑤ Nauru Program Office performs thorough due diligence checks
- ⑥ Receive Pre-Approval Confirmation
- ⑦ Finalize qualifying investment (Treasury Fund contribution)
- ⑧ Receive Final Approval; take Oath of Allegiance
-  Nauruan Citizenship Certificate & Passport Issued

Main applicant requirements



We welcome applicants aged 18 and above with a clear background.



Clean criminal record; restricted nationalities include Afghanistan, Belarus, Iran, North Korea, Russia, Sudan, Yemen



Good health is required; a medical exam is part of the process.
