## Procedures

*The Vanuatu Citizenship Office & Commission reviews all applications after a thorough due diligence check by the Financial Intelligence Unit (FIU).*

- ① Engage Citiverse as your authorized agent
- ② Citiverse guides document preparation (passport copies, police clearances, medical certificates)
- ③ Client agreement signed, retainer paid
- ④ FIU performs thorough due diligence checks (typically 3-7 days)
- ⑤ Application prepared & submitted to the Citizenship Commission via Citiverse
- ⑥ Receive Approval in Principle
- ⑦ Finalize qualifying investment & pay remaining government fees
- ⑧ Submit biometrics in person (at designated locations) and take Oath of Allegiance (can be done remotely)
-  Vanuatu Passport Issued

## Main applicant requirements



We welcome applicants aged 18 and above with a clear background.



Applicants must provide proof of a legitimate source of funds and a minimum of \$250,000 USD in their bank account.



Good health is required; a medical exam is part of the process.



Investment Options

- **Development Support Program (DSP) Contribution**
  - Min. USD 130,000 (non-refundable) for a single applicant
- **Real Estate Option (REO) Purchase**
  - Min. USD 200,000 in an approved project (hold for 5 years)
  - Real Estate by Share: Min. USD 105,000 for a single applicant
- **Capital Investment Immigration Plan (CIIP)**
  - Min. USD 157,000 investment, with a portion being partially refundable after 4-5 years
